On March 24th, at the UN Commission on the Status of Women conference, hosted a panel discussion on "How Effective Partnerships in Healthcare and Education are Transforming Lives" that was attended by 100 participants.

In response to the humanitarian crises in Puerto Rico and the the Caribbean, the UNFCU Foundation conducted an online fundraising campaign to bring aid to those residing in areas affected by Hurricane Maria. The campaign raised \$9,667.88. The UNFCU Foundation matched the donations, which brought the total to \$18,935.80. All proceeds were donated to UNICEF - USA to further its efforts to help thousands of families living in devastated areas. UNFCU Foundation raised \$23,441.09 for Yemen through a dedicated public fundraising effort to curb the spread of cholera.. The UNFCU Foundation matched the funds raised which brought the total to \$46,882.19. All proceeds were donated to the "WASH" (water, sanitation and hygiene) program to aid women and children affected by the cholera epidemic.

The UNFCU Foundation accepts grant applications from US registered 501 (c)(3) nonprofit organizations and those working with UN entities on the ground globally. The grant application process begins in June of each year. In 2017, the UNFCU Foundation processed and reviewed over 100 grant applications during that period. The UNFCU Foundation approved 13 projects that aligned with its mission to sustain a path out of poverty through health care and education for women and youth, and funded a total amount of \$465,000. Grants approved by the UNFCU Foundation Board of Directors for 2018 and disbursed in December 2017 are: Khaled Hosseini Foundation to enable 800 girls to attend Khurasan Learning Center in Afghanistan and 80 women to receive literacy and vocational training; the Floating Hospital's Mental Health Program in New York City for 825 at-risk women and girls as well as extend outreach to homeless women and girls in shelters and domestic violence safe houses. i; Village Enterprise for the expansion of Microenterprise Development Program in Northern Uganda to provide economic opportunities for 300 women; Keep a Child Alive to support HIV/AIDS Medical Services Program for 7,000 women and girls in Kampala, Uganda; UN Foundation/Girl Up - Action for Adolescent Girls Program to train 50 peer mentors across 200 communities in Guatemala ; UNFPA's Fistula Foundation in Nigeria to expand treatment to 200 obstetric fistula survivors; Trickle Up Economic Empowerment Program for 250 indigenous Mayans, Q'eqchi, and Quiche, children and families in Guatemala; Kilimanjaro Initiative youth programs that empower young people to overcome socio-economic obstacles and promote non-violence in Nairobi, Kenya; LIC YMCA Summer Programs for 70 at-risk youth; Batey Relief Alliance Training Programs for 100 women and free healthcare services for 450 children in bateys areas in Dominican Republic; Women for Women International to establish and train 20 savings groups that will teach 250 women in Nigeria how to start, grow, and, manage micro-business .
