## Explanation

GRANT MAKING: The UNFCU Foundation accepts grant applications, during the month of June, from US registered 501(c)(3) nonprofit organizations and those working with UN entities on the ground globally. During 2018, the Foundation reviewed 60 grant applications and approved 14 projects that aligned with its mission to sustain a path out of poverty through healthcare and education for women and youth. In December 2018, funds totaling \$571,000 were distributed. The grants approved by the UNFCU Foundation Board of Directors for 2019 are the following: Association of Volunteers International Service, USA to train 100 girls (ages 13 - 19) and 150 women (ages 20-35) within livelihood training groups and psychosocial resilience workshops in Nairobi, Kenya. Batey Relief Alliance to provide field-based agricultural training to 100 women along with support for start-up and technical assistance to adopt market-oriented strategies within impoverished rural communities, "bateyes," in the Dominican Republic. UN Foundation/Girl Up to empower 189 marginalized adolescent girls in Liberia in three key communities in Montserrado County to take control of decision-making and peacebuilding processes and to improve access to formal education for out of school adolescents. International Rescue Committee to provide job readiness training to 26 refugee women located in Maryland. Kilimanjaro Initiative's women psychosocial support and empowerment program to provide business training to 16 young women along with a psychosocial support system in Kibera. The BOMA Project's Rural Entrepreneur Access Project (REAP) provides business and financial training to 115 women as well as the empowerment to become decision-makers within households in Kenya. The Floating Hospital's Mental Health Program will serve for 130 at-risk women and girls as well as extend outreach to homeless women and girls in shelters and domestic violence safe houses. The Khaled Hosseini Foundation to enable 400 girls to attend Khurasan Learning Center (KLC) in Afghanistan and operate two women's literacy programs at KLC. Together We Bake serves low-income women involved with the criminal justice system and facing long-term unemployment by providing workforce training and psychosocial support to 27 women including post program support to 30 alumni within Washington, D.C. Trickle Up Program, Inc. to provide the Graduation Approach methodology to 98 women to establish livelihood plans and establish savings groups within Guatemala. UNFPA's Fistula Foundation in Nigeria to provide free fistula treatments to 150 unserved women/girls and train 100 community health workers for preliminary screenings. Village Enterprise to provide economic opportunities for 240 first-time women entrepreneurs to start small businesses and form business savings groups in Nigeria. Women for Women International to establish and train five (5) savings groups that will teach 100 women in Nigeria about entrepreneurship and financial literacy. Women in Need's Income Building Program will provide basic computer training to 75 women in New York City, who are unemployed or underemployed, and assist the program graduates seek clerical jobs through job searches, resume preparation and mini job fairs. Additional funds of \$98,029 were distributed to the Kilimanjaro Initiative (KI) youth programs, including the KI Africa Golf Project, that empower young people to overcome socio-economic obstacles and promote nonviolence in Nairobi.
